NEW BUSINESS

1. Paul Hughes Settlement

Mary Alice Bryant made the motion to approve settlement of the matter initiated by Paul Hughes against the Borough currently pending before the EEOC at Charge no. 533-2020-00346 in the amount of \$17,500, and authorize proper Borough officials to execute any documents and take any such other action necessary to effectuate the same. Second by Tyson Klukan.

Council Comments:

- Vicki Schaub asked how it was decided on the dollar amount. Settlement negotiations have been going back and forth.
- Alyssa Golfieri stated months ago Council authorized and was brought up to date
 on how the settlement was going. The dollar amount is within the range that the
 council was comfortable with. The goal is to have it resolved by the end of 2021.

2. IDC Option

Josh Adams made the motion to approve and authorize proper Borough officials to execute an Option Agreement with the Armstrong County Industrial Development Council for a 120-day term and \$1,000 consideration related to 30 acres of real property owned by the Borough located on 2nd Avenue at the southern end of the Borough adjacent to the river commonly referred to and known as the "Brownfields," in a form acceptable to the Borough Solicitor. Second by Vicki Schaub.

Council Comments:

- Tyson Klukan stated that this is monumental for the Borough. The past administration could not get this done. He also stated that there has been a lot of hours have been put into this and that the organizations goal is to help further economic development.
- Josh Adams is glad to see something moving forward.

3. Milling Quote Approval

Mary Alice Bryant made the motion to accept, as recommended by the Public Works Committee, a quote in the amount of \$10,000 from Hiles Excavating LLC for the milling of Ridge Avenue, subject to receipt of PennDOT's approval of the use of Liquid Fuel funds, and to authorize proper Borough officials to take any such action and execute any related documents or agreements necessary to effectuate the milling, subject to all such documents or agreements being in a form acceptable to the Borough Solicitor. Second by Josh Adams.

Council Comments:

- Vicki Schaub asked if any other quotes were received.
- Carol Fenyes stated not for this as it's under the bid threshold. And, Kevin did reach out to Whites Paving and they stated they did not have time.
- Tyson Klukan stated when Shields was in town, they did a general assessment and they determined their schedule was too busy for the year. And, to answer Laurel's question, the next step would be to bring the engineer in on this.
- Josh Adams adds that getting to this step was a lot quicker than other projects and that Phase Two may not go as quickly as this. (Josh Adams stated this was just his opinion).

4. Actuarial Valuation Reports

Second by Josh Adams.

- Tyson Klukan questioned if the Borough received Borough Pension Plan Audit Reports. And, asked if this will impact any kind of findings from the previous audit reports.
- Carol Fenyes stated this is two different things. Actuarial Evaluations have recommended a slight change in interest rate assumption. The Pension Plan audit report came out just today and was not on the agenda due to not having time to review.
- Vicki Schaub asked if this is due at the end of September.
- Carol Fenyes said no, the MMO needs to be voted on by the end of September.
