INTERIM ASSESSMENT & TAXATION – ARMSTRONG COUNTY

Jeanne Englert – Armstrong County Tax Claim, explained the interim billing resolution adopted by the Armstrong County Commissioners. This will begin in 2018 for new structures only. Englert provided a sample resolution for a municipality. If Ford City Borough would adopt the resolution, information would be sent to the local Tax Collector for distribution by September 1 of each year. This interim billing would not include any special taxes.

WEST PENN POWER

Rob Lombardo – First Energy, explained the plan to change the Street Lights to LED with smart meters. If the change could be pushed to the end of 2018 there would be a cost reduction. The 200 Watt would change to a 90 LED and the 100 Watt would change to a 50 LED. The LED is a clear light the Police & Street Depts. like. The LED is a direct downward light, not a lot of halo. The light rate is cheaper less KWH going from Sodium to LED.
