OLD BUSINESS

1. CRACK SEALING

Bryant motioned to accept, as recommended by the Public Works Committee, a quote in the amount of \$11,496.00 from Russell Standard for the sealing of cracks on (i) 4th Avenue between 12th and 14th Street, and between 4th and 7th Street, (ii) 3rd Avenue between 12th and 14th Street, and (iii) 6th Avenue between 7th and 9th Street, subject to receipt of PennDOT's approval to use Liquid Fuel funds, and to approve and authorize proper officials to take any such action and execute any related documents or agreements necessary to effectuate the crack sealing, subject to all such documents or agreements being in a form acceptable to the Borough Solicitor. 3. F.C.B.M.D.S.A.

Bryant motioned to approve and authorize proper Borough officials to execute a Sanitary Sewer Easement Agreement with the Ford City Borough Municipal Sewage Disposal Authority granting the Authority (i) a 25 ft temporary right-of-way and easement for construction purposes, and (ii) a 20 ft perpetual right-of-way and easement for the purpose of maintaining and repairing the new sanitary sewer force main along 3rd Avenue between 11th Street and 14th Street, in a form acceptable to the Borough Solicitor and Engineer. Adams seconded. 4-0 Unanimous

Adams motioned to approve and authorize proper Borough officials to execute a Sanitary Sewer Easement Agreement with the Ford City Borough Municipal Sewage Disposal Authority granting the Authority (i) a 24 ft temporary right-of-way and easement for construction purposes, and (ii) a 16.5 ft perpetual right-of-way and easement for the purpose of maintaining and repairing the new sanitary sewer force main along 3rd Avenue between 14th Street and 17th Street, in a form acceptable to the Borough Solicitor and Engineer. Bryant seconded. 4-0 Unanimous
