DISCUSSION ITEMS

-Federal appropriations request

Charles Stull, Ford City Borough Manager, discussed his process with applying for funding through GT Thompson's federal appropriations requests. In the five-calendar day window, he was able to work with the Borough Engineer to apply for \$1.8 million in funding to rehab the stormwater system. The request is now in the process of being approved by the Appropriations Committee.

-Lower PPG pump yard pump station

Drew Klezek, Ford City Borough Public Works Director, updated the board on the current state of the lower yard PPG pump station and what the borough is doing to manage the situation. The lower pump house only has one working pump, and it is drastically being overworked. His recommendation is to eventually have two fully functional pumps and rehab the existing pump. In the meantime, the borough will utilize the gravity gate when possible, to assist the remaining pump.


