**AN ORDINANCE OF THE BOROUGH OF FORD CITY, ARMSTRONG COUNTY, PENNSYLVANIA, ADOPTING THE FORD CITY BOROUGH CODE OF ORDINANCES, CONSOLIDATING, REVISING, AMENDING AND REPEALING CERTAIN ORDINANCES, ENACTING CERTAIN NEW PROVISIONS, PROVIDING FOR REPEALER, AND ESTABLISHING SEVERABILITY AND EFFECTIVE DATE PROVISIONS.**

**WHEREAS**, Section 3301.5 of the Pennsylvania Borough Code, 8 Pa.C.S. § 3301.5, empowers and authorizes the Borough of Ford City (the “Borough”) to revise, amend, restate, codify and compile any existing ordinances and all new ordinances not heretofore adopted or published and to incorporate such ordinances into one ordinance in book form; and

**WHEREAS**, the Council of the Borough has authorized a general compilation, revision and codification of the ordinances of the Borough of a general and permanent nature and publication of such ordinance in book form; and

**WHEREAS**, the Council of the Borough desires to enact an ordinance adopting the codification of the general body of Borough ordinances, known as the “Ford City Borough Code of Ordinances.”

**NOW, THEREFORE**, the Council of the Borough of Ford City hereby ordains and enacts as follows, incorporating the above recitals by reference:

**SECTION 1.** The general ordinances of the Borough of Ford City as revised, amended, restated, codified, and compiled in book form are hereby adopted as and shall constitute the “Ford City Borough Code of Ordinances.”

**SECTION 2.** Such Code of Ordinances as adopted in Section 1 shall consist of the following Titles:

**SECTION 3.** All prior ordinances pertaining to the subjects treated in such Code of Ordinances shall be deemed repealed from and after the effective date of this ordinance except as they are included and reordained in whole or in part in such Code; provided, such repeal shall not affect any offense committed or penalty incurred or any right established prior to the effective date of this ordinance, nor shall such repeal affect the provisions of ordinances levying taxes, appropriating money, annexing or detaching territory, establishing franchises, or granting special rights to certain persons, authorizing public improvements, authorizing the issuance of bonds or borrowing of money, authorizing the purchase or sale of real or personal property, granting or accepting easements, plat or dedication of land to public use, vacating or setting the boundaries of streets or other public places; nor shall such repeal affect any other ordinance of a temporary or special nature or pertaining to subjects not contained in or covered by the Code.

**SECTION 4.** The provisions of the Ford City Borough Code of Ordinances, so far as they are the same as those ordinances and regulations in force immediately prior to the adoption of said Code, are intended as a continuation of such ordinances and regulations and not as a new enactment. The provisions of the Ford City Borough Code of Ordinances shall not affect any suit or prosecution pending or to be instituted to enforce any of the prior ordinances or regulations. Unless otherwise stated herein, in the event of any conflict between any provisions or regulations of this Code, then the stricter regulation shall govern.

**SECTION 5.** This ordinance shall become effective immediately upon publication of notice of final enactment as required by law.

**SECTION 6.** It is hereby declared to be the intention of the Borough Council that the titles, sections, paragraphs, sentences, clauses and phrases of this codification are severable. If any section, paragraph, sentence, clause or phrase of this Code is declared unconstitutional, illegal or otherwise invalid by the judgment or decree of a court of competent jurisdiction, that invalidity shall not affect any of the remaining title, section, paragraph, sentence, clause or phrase of this codification.

**SECTION 7.** It shall be the responsibility of the Borough Secretary to maintain an up-to-date certified copy of the Code of Ordinances. This copy shall be the official copy of the Ford City Borough Code of Ordinances and shall be available for public inspection.

**SECTION 8.** The Code of Ordinances does not include the Borough's Zoning Ordinance which will remain in full force and effect as a stand-alone ordinance of the Borough.
